Applications of suitable BS-21/22 officers having following qualification and experience, are invited to fill up the vacant post of Ambassador for Permanent Mission of Pakistan to the WTO, Geneva:

a.	All serving officers in BS-21/22 may apply for said post.
b.	Having Master's degree of Business Administration, Public Administration, Public Policy, International Law, Economics, International Trade, Law (General), Management Sciences, Investment Promotion Management, Commerce or related field.
c.	Having served in Federal Government in Prime Minister's Office, Ministry of Commerce, Trade Development Authority of Pakistan (TDAP), Economic Affairs Division, Federal Board of Revenue, Board of Investment, Privatization Commission, Ministry of National Food Security & Research, Finance Division, Ministry of Industries and Production, Chief Minister's Offices, Provincial Departments of Finance, Revenue, Planning & Development, Agriculture, Commerce, Investment and Industries or any related field. Experience in Trade/Multilateral negotiations and experience in post relevant to WTO would be given preference.
d.	Upper age limit is 56 years (on the closing date of submission of application).
e.	All Such interested officers are required to provide: - <ul style="list-style-type: none"> i. C.V showing personal data with photographs giving details of experience and education qualification. ii. Certificate from parent Ministries/ Divisions/Departments that there is no disciplinary/criminal proceedings pending and the officer is not a beneficiary of plea bargain or NRO. iii. The nominee has not served in any Mission abroad for last 03 years. iv. Certificate of discloser to the effect whether a candidate/nominee has remained posted abroad earlier or not. v. Certificate from relevant Ministries/Divisions/Departments that the officer has never been recalled from a foreign post by the Government of Pakistan/Parent Department, previously on account of poor performance. vi. PERs grading for the last 05 years in case of applicants of BS-21 shall be provided by the shortlisted candidates.

All Ministries/Divisions and the Provincial Governments are requested to forward suitable nominations to Joint Secretary (T), Establishment Division, Pak-Secretariat, Cabinet Block, Islamabad by 28.04.2023. Incomplete nominations and those received after due date will not be entertained. Moreover, applications will be considered only when received through their parent/administrative departments/Division within due date, complete in all respects along with documents specified above.
